Terms & Conditions

These Terms and Conditions and any additional terms and documents referred to on the face or back hereof constitute the entire agreement (collectively the "Purchase Order") between the BJP Office entity that issues this Purchase Order ("BJP Office") and Supplier ("Supplier") that supplies or provides the goods or services ordered by BJP Office hereunder (hereinafter "Services" or "Goods" whichever is applicable).

1. **ACCEPTANCE.** Supplier's commencement of Services or delivery of Goods, whichever occurs first, or any other event that constitutes acceptance under applicable law, shall be deemed unconditional acceptance of this Purchase Order and as Supplier's waiver of any additional terms of any confirmation, invoice or other writing issued by Supplier.
2. **DELIVERY AND RISK OF LOSS.** The obligation of Supplier to meet the terms of delivery, specifications and quantities is of the essence of this Purchase Order. Supplier assumes full responsibility for packing and transportation and shall bear the liability for loss, destruction or damage until Goods are delivered to BJP Office even if BJP Office has agreed to reimburse transportation costs.
3. **CHANGES.** Upon reasonable notice to Supplier, BJP Office shall have the right prior to the shipment date of Goods to make changes in quantity, specifications, time and place of delivery and method of transportation.
4. **INSPECTION.** Payment for Goods/Services delivered shall not constitute acceptance thereof. BJP Office shall have the right to inspect such Goods/Services and to reject any or all of said Goods/Services which are, in BJP Office's sole reasonable discretion, defective or nonconforming to the agreed quantity, quality or specifications. Rejected Goods may be returned to Supplier at Supplier's expense.
5. **OWNERSHIP OF WORK.** As a result of Supplier's access to BJP Office's confidential information and/or in the performance of Services and/or in the creation of Goods, Supplier may produce deliverable materials, including but not limited to know-how, designs, mask works, trademarks, processes, trade secrets, ideas, artwork or other copyrightable or patentable works ("Work Product"). Supplier agrees that all right, title and interest in and to the Work Product shall be owned exclusively and perpetually by BJP Office, except for Supplier's intellectual property developed prior to entering into this Purchase Order. To the extent ownership of any Work Product does not by operation of law vest in BJP Office, Supplier hereby assigns, sells, transfers, grants, and conveys all right, title, and interest in such Work Product to BJP Office, including without limitation, the exploitation intellectual property rights to make any reproduction, distribution, public communication and transformation of such Work Product by any and all means worldwide. Supplier shall not enforce any of its intellectual property rights (including patent, trademark or copyright rights) against BJP Office for any product that includes or incorporates any Goods or Services.
6. **WARRANTY.** Supplier warrants that: (a) the prices for Goods/Services sold to BJP Office under this Purchase Order are not less favorable than those currently extended to any other customer for the same or like Goods/Services in equal or less quantities; (b) all Goods/Services shall be of merchantable quality, free from all latent or patent defects, shall conform to BJP Office's specifications or samples, and shall be safe for their intended use and shall be free and clear of all claims, encumbrances and third party rights; (c) Goods/Services have been produced in compliance with and Supplier agrees to be bound by all applicable federal, state and local laws, orders, rules and regulations; (d) Goods/ Services do not infringe any patent, trademark or copyright or any other third party right; and (e) Supplier owns or has a right to sell Goods and provide Services. Furthermore, Supplier warrants that it will perform Services in a workmanlike manner.
7. **TERM AND TERMINATION.** This Purchase Order expires when Goods/Services are accepted by BJP Office, unless earlier terminated as provided herein. If Supplier becomes insolvent or the subject of bankruptcy or assigns its assets for the benefit of creditors, or if Supplier fails to cure any breach within ten (10) business days after written notice, BJP Office may suspend or terminate performance of any obligation under this Purchase Order and purchase substitute Goods/Services elsewhere and charge Supplier with any losses or costs incurred and exercise any other legal rights or remedies. Furthermore, BJP Office reserves the right without liability to Supplier to terminate for no cause all or part of this Purchase Order by written notice to Supplier, provided that BJP Office shall compensate Supplier for all pre-approved costs and expenses incurred up to the date of termination.
8. **DAMAGES.** BJP Office shall be entitled to charge Supplier 1% of the total price of Goods/Services per each calendar day of delay from the agreed delivery date up to their actual delivery date but excluding the delivery date. BJP Office shall be entitled to charge Supplier 10% of the total price of Goods/Services in case Goods are not delivered and/or Services are not rendered. Goods are considered to be not delivered and Services are considered to be not rendered if the delay continues more than ten (10) business days or if Goods/Services are not accepted.
9. **LIMITATION OF LIABILITY AND INDEMNITY.** In no event shall BJP Office be liable for any loss of profits or business, any consequential, special, indirect or punitive damages, even if BJP Office has been advised of the possibility of such damages. Supplier agrees to indemnify and hold BJP Office, its units, affiliates, officers, employees and agents harmless from and against all claims, liabilities, expenses, losses or damages (including attorneys' fees) to which BJP Office may become subject insofar as such claims, liabilities, expenses, losses or damages arise out of or are based upon (a) Goods purchased or Services ordered from Supplier; (b) a breach by Supplier of any of the warranties contained herein; or (c) the negligent acts or omissions of Supplier's officers, directors, employees or agents. Supplier shall defend any such suits at its sole cost and expense and BJP Office shall have the right to have such litigation monitored by its own counsel.
10. **FORCE MAJEURE.** Neither party shall be liable for delays or failures in performance of any obligations under this Purchase Order due to a cause beyond its reasonable control.
11. **INSURANCE.** Supplier warrants that it carries sufficient limits of worker's compensation, product liability and general commercial liability coverages. BJP Office shall be named as an additional insured under applicable coverages.
12. **CONFIDENTIALITY.** Without BJP Office's prior written consent, Supplier agrees that any information obtained or learned by Supplier in connection with this Purchase Order shall be kept confidential and used only for the purposes of this Purchase Order and shall not be disclosed to any third party except to those employees or agents of Supplier who have a specific need to know or when required by law.
13. **MISCELLANEOUS.** In addition to BJP Office's rights and remedies provided herein, BJP Office reserves the right to seek any other rights and remedies provided by applicable law or in equity. If any provision is declared invalid, illegal or unenforceable, the validity of the remaining provisions shall not be affected. The parties agree that this Purchase Order shall not be presumptively interpreted for or against any party by reason of that party having drafted or negotiated, or failed to draft or negotiate, all or any portion of any provision of this Purchase Order. This Purchase Order shall be governed by and construed in accordance with the laws of the city and country where the BJP Office is located, without regard to its conflicts of laws principles. Any rights or obligations arising hereunder may not be assigned or delegated by Supplier without BJP Office's prior written consent. No waiver or amendment of any provision of these Terms and Conditions shall be effective unless in writing and signed by both parties. The relationship between Supplier and BJP Office is and shall be that of independent contractor, and Supplier shall not be deemed to be an agent or employee of BJP Office. Provisions 1, 5, 6, 8, 9, 11, 12, and 13 shall survive the termination or expiration of this Purchase Order.
