

## **Certification of Trust for the 2013 Yan Family Trust dated December 11, 2013**

The 2013 Yan Family Trust (the *Trust*) was established on December 11, 2013. The Grantors of the Trust are Kelvin Yan and Helen Su Irving-Yan. The Trustees are Kelvin Yan and Helen Su Irving-Yan (referred to collectively as the *Trustee*).

The signature of any Trustee is sufficient to exercise the powers of the Trustee.

This Trust is revocable and amendable by Kelvin Yan and Helen Su Irving-Yan, acting jointly.

The address of Kelvin Yan, Trustee, is 2810 Domingo Road, Fullerton, California 92833.

The address of Helen Su Irving-Yan, Trustee, is 2810 Domingo Road, Fullerton, California 92833.

The tax identification number of the Trust is the Social Security number of Kelvin Yan.

Title to assets in the Trust will be taken as follows:

Kelvin Yan and Helen Su Irving-Yan, Trustees, or their successors in interest, of the 2013 Yan Family Trust dated December 11, 2013, and any amendments thereto.

In addition, for titling purposes, any description referring to the Trust is effective if it includes the name of the Trust, the name of at least one initial or successor Trustee, and any reference indicating that property is being held by our Trustee in a fiduciary capacity.

The Trustees under the trust are authorized to acquire, sell, convey, encumber, lease, borrow, manage, and otherwise deal with interests in real and personal property in trust name. The Trustee powers are set forth in Article Sixteen.

The 2013 Yan Family Trust has not been revoked, modified, or amended in any way that would cause the representations in this Certification of Trust to be incorrect.




**RELIANCE ON THIS CERTIFICATION**
